The 1st Academic Council Meeting of COEP Tech post the constitution of all statutory committees as per the COEP Technological University Act, dated 10th May 2022, issued by the Government of Maharashtra commenced with Dr. D. N. Sonawane, Registrar and Member Secretary of the Academic Council formally welcoming all the members. The attendance of all the members present was recorded in the proceeding book.

#### Ag-1: Introduction of Academic Council Members.

Dr. D. N. Sonawane, Registrar and Member Secretary of the Academic Council presented the composition of the new Academic Council of the university which was constituted as per the section 25 of COEP Technological University Act, dated 10<sup>th</sup> May 2022, issued by the Government of Maharashtra, and requested the Vice Chancellor, Prof. Agashe to address the members followed by the members present for the meeting to formally introduce themselves.

Prof. Sudhir Agashe, Vice Chancellor, COEP Tech, formally welcomed all the members present in person and online appealed all to collectively contribute for addressing various challenges faced by the university on academic front and making COEP Tech an NEP compliant university in the near future.

### Ag-2: Confirmation of Minutes of 12th Academic Council.

Dr. D. N. Sonawane, Registrar and Member Secretary of the Academic Council placed the minutes of the 12<sup>th</sup> meeting of the Academic Council held on 3rd December 2022, before the members for confirmation and approval. He also presented the action taken report on the decisions made to the Academic Council members. He clarified the doubts of the Academic Council members on the action taken report satisfactorily. The minutes of the previous meeting were approved by all the present members.

**R-AC-1-2:** The members RESOLVED to APPROVE the Minutes of the 12<sup>th</sup> meeting of the Academic Council of the Institute held on 3<sup>rd</sup> December 2022. The members also approved the actions taken by the institute based on the decisions made in the previous meeting.

- Ag-3 i: Approval of Examination Results and the Analysis of Graduating Batches of AY 2022-23: All UG Programmes.
- Ag-03 ii: Approval for the list of Programme-wise Toppers and Rank Holders: All UG Programmes of AY 2022-23.



Dr. (Ms.) Yashodhara Haribhakta, Director- Board of Examination and Evaluation was invited to present before the members the department wise examination results of all the UG Final Year students and its analysis done based on various parameters. Since the Industrial Implant Training of the Final Year students Production Engineering (Sandwich) programme is yet to be completed, their result analysis was not presented.

She also presented the programme-wise list of students (except for Production Engineering Sandwich programme whose results are delayed due to IIPT Exam) who have topped in the examinations and the overall topper for the approval of the council.

She presented the comparative analysis of the success index in terms of graduate outcomes over the last 5 academic years for all the UG Programmes and Honors and Minor Courses.

Dr. S. P. Mahajan suggested having a separate analysis of the students' performance through all the semesters for Honors/ Minor certification programme which will aid framing NEP implementation policy. Dr. S. S. Dambhare raised the concern that the departments are currently challenged with the faculty crunch. Inspite of lesser number of students opting for the Minor/ Honor scheme the department have to engage a dedicated faculty for these students, which becomes a pressing situation for the departments. Dedicated efforts must therefore be undertaken to revamp these certification programmes in order to attract a greater number of students to opt for the Honor/ Minor certification. A central level committee should therefore be appointed who will look into the matter and take the required precautionary measures.

#### Ag-03 iii: Approval for the amendments in examination reforms.

Dr. Haribhakta also sought approval from the house for the following.

#### 1. Amendment in Re-examination rules

- ✓ The university has continued with the Autonomous COEP Academic and Examination rules and regulations for UG/PG/PhD Programme with an amendment in re-examination rules.
- ✓ In University, re-examination will be conducted only once after the result declaration of even semester (in summer) for both semesters unlike before wherein examination was held after the end of every semester.

#### 2. Evaluation of Project/Dissertation

✓ Project/ Dissertation evaluation is currently carried out in two parts.
 Continuous Internal Evaluation: 50 Marks (called as term work)
 End Sem Evaluation (Oral Eaxm): 50 Marks (external evaluation)

#### ✓ Proposed amendment:

Continuous Internal Evaluation: 70% weightage End Sem Evaluation (Oral Eaxm): 30% weightage

#### 3. Procurement of Pre-printed Semester Grade Reports

✓ To maintain the security and confidentiality of pre-printed semester grade report, the process of procurement would be handled by Examination and Evaluation cell by inviting specific limited quotations of vendors specialized in providing secured preprinted grade reports.



#### 4. Conversion of CGPA to grade letter required for MBA DEGREE FORMAT

✓ Since the MBA students passed out in AY 2021-22 and AY 2022-23 are affiliated to Savitribai Phule Pune University (SPPU), to get the degree from SPPU, final CGPA should be converted into grade letter as shown in table below:

#### 5. MOOC NPTEL Policy

- ✓ Score out of 100 of NPTEL examination would be directly considered for grading.
- ✓ Students not able to secure a passing score in NPTEL examination, the university will conduct subjective End Sem exam.
- ✓ The internal scores would be carried from NPTEL assignments.

#### 6. Director, BE&E to act as Signing Authority in capacity of Controller of Examination

- ✓ Director, Board of Examinations and Evaluation of COEPTech University be designated to act as signing authority in capacity of COE for all matters pertaining to students of COEP college before and after autonomy.
- ✓ In absence of Director, BE&E, Registrar will be the signing authority in capacity of COE.

**R-AC-1-3:** The members RESOLVED to APPROVE the UG Examination Results and Analysis of Graduating Batches of AY 2022-23, list of Programme-wise Toppers and Rank Holders for UG Programmes of AY 2022-23, Proposed amendments in the examination reforms.

#### Ag-04: Approval of Academic Calendar (AY: 2023-24).

In order to make an appropriate balance between the curricular and co-curricular activities Dr. (Ms.) Yashodhara Haribhakta, Director- Board of Examination and Evaluation and Dr. Mohan Khond, Director- Board of Students Development after many brains storming sessions prepared the Academic Calendar for AY 2023-24 and presented the same before the members. Major highlights of the said calendar are as follows.



- ✓ Instead of dedicating 3 days for conducting T1, T2 exams, the faculty will be able to conduct T1/ T2 during an entire week before or after the regular academic hours.
- ✓ Out of the 4 flagship events (Mindspark, Zest, Impression, Regatta) 3 will be held in the 1<sup>st</sup> semester of which 2 during winter vacations.
- ✓ Most of the events to be held on weekends, public holidays.
- ✓ Club activities to be held after the day's academics.

Dr. khond stated that the above changes will facilitate in getting uninterrupted 13 weeks for academics. Mr. Shankar Deshpande suggested mentioning foundation day of the university in the Academic Calendar, to be observed with equal gusto and spirit every year.

#### R-AC-1-4: The members RESOLVED to APPROVE the Academic Calendar for AY 2023-24.

# Ag-05: Presentation of Placement Outcome and its Analysis of Graduating Batches of AY 2022-23: All UG and PG Programmes

Ms. Viveka Singh, Associate Training and Placement Officer presented the placement statistics for AY 2022-23 for UG and PG Engineering and MBA Programmes. She also gave an overview of the placement scenario at COEP Tech over last three years and the placement policy.

With a slight relief with the growing Highest, Average salary offered by the companies major concern was raised pertaining to the lower placement figures for the students of B. Planning Programme. Mr. Shankar. C. Deshpande, Chief, Town & Country Planning Division at Mumbai Metropolitan Region Development Authority, Mumbai stated that the lower placement figures for the Planning Graduates contradicts to the growing demand of Planners especially in the Metro cities.

Mr. Deshpande generously offered to help COEP Tech to reach out such employers seeking competent Planning Graduates. The following suggestions were made by the members to T&P cell.

- ✓ To aggressively reach out to potential employers and corporates especially for the Placement of Planning students as they don't have bulk companies coming for placement unlike the Engineering Companies.
- ✓ Maintain separate statistics for students undergoing internships and the pre placement offers generated from the students internships.
- ✓ No. of students gone for higher education and self-employment should also be considered as placed candidates.
- ✓ Separate statistics to be maintained based on the students placement in Core vs IT companies.
- ✓ Establish a hardship redressal scheme for students getting rejected after selection by a
  particular company.



**R-AC-1-5:** The members RESOLVED to APPROVE the placement statistics and the placement policy presented by T&P cell.

# Ag-06: Approval of Proposed Academic Structure of B Tech Program on "Robotics and Artificial Intelligence" proposed to start from AY: 2023-24

Dr. S. S. Ohol, presented the curriculum for the B Tech Program in "Robotics and Artificial Intelligence" proposed to start from AY: 2023-24. Dr. Ohol mentioned that the said curriculum structure is based on AICTE guidelines and designed for all the AICTE approved technical institutions offering a similar programme under Robotics and Artificial Intelligence. The members suggested to have the credits distributions for the said programme in such a way that it can categorically fall under Mechanical/ Electrical group of Engineering programme or as a separate Programme for smoothly conducting all the academic activities. Also, to place the proposed curriculum before the school councils for deliberations and then for the approval of the Academic Council. Dr. Ohol said that the proposed curriculum structure will be revisited and modified as per the given suggestion.

**R-AC-1-6:** The members RESOLVED that the proposed curriculum structure needs to be revisited and modified as per the given suggestion and placed in the next Academic Council meeting for approval.

#### Ag-07: Approval of increase in intake of existing MBA program from AY: 2024-25

In view of the increasing number of students willing to get admission to the MBA (General Management) programme at COEP Tech, Dr. Sandeep Meshram, Dean, School of Transdisciplinary Sciences and Management proposed to increase the current sanction intake from 30 to 60 from AY 2024-25. Dr. Meshram justified his proposal with the following points.

- ✓ Demand for MBA at COEP: Every year before admissions we get several enquiries through phone calls and physical walk-ins to the MBA department. Ever since COEP Tech started with the MBA program, we have got more than 150+ applications for the seats available after all the CAP rounds during the admission process, suggesting a high demand for this program. Refusing candidates who are willing to join COEP Tech is very unfortunate and sabotages our image.
- ✓ Compliance with Regulatory Norms: The program started with proper approval from the AICTE. However, COEP being a university now, the increase in intake is subject to approval from the Academic Council.
- ✓ Increasing the Scope of Electives: Presently we are offering only 2 elective baskets and cannot add more to the list because we have a small batch. With this increase in the batch



size, it will give us freedom to increase the number of electives and provide varied opportunities and expertise to the students.

The members suggested Dr. Meshram to present the statistics based on the admissions and placement of the MBA students in the next Academic Council meeting.

**R-AC-1-7:** The members RESOLVED to APPROVE increase in intake of existing MBA program from AY: 2024-25

Ag-08: Approval on credit transfer students from other Govt. and Govt. Aided Engineering Colleges across the state from AY: 2023-24

Dr. P. P. Bartakke, Dean - School of Electrical and Communication Engineering said that heading towards being an NEP compliant university, as an outreach activity the university wish to extend

the scheme of inducting students for credit transfer from other Govt. and Govt. aided Engineering Colleges across the state of Maharashtra to COEP Tech University with a cap of 160 students across all the branches for two semester. However there exist certain implementation issues as given below which will discussed and finalized in respective school council and the final action plan will be submitted to Hon. VC for his approval.

- Entry allowed at SY (Sem III and IV) and TY (VI and VI) levels.
- Number of students: 10% of sanction intake.
- Selection process: By the participating Govt. and Govt. Aided institutes; responsible to verify prerequisite of courses.
- Fees: course-wise, credit based.
- Food and stay arrangements: to be done and borne by students/parent institutes.

He requested the Academic Council members to in principle approve the noble initiative.

**R-AC-1-8:** The members RESOLVED to APPROVE in principle the of inducting students for credit transfer from other Govt. and Govt. aided Engineering Colleges across the state of Maharashtra to COEP Tech University.



#### Ag-09: Existing Fees Structure and Proposal to increase the Fees from AY: 2023-24

Prof. Manoj Rathod, Finance and Accounts Officer COEP Tech stated that as an Autonomous institute of Govt. of Maharashtra the institute was empowered to increase the fees every year by 10%. However, pertaining to the Covid'19 pandemic, the institute did not make any rise in fees. Considering the growing inflation and expenses and after a thorough study of per student expenditure and the income, the University now proposes to increase the fees by 25% from the upcoming Academic Year. Dr. Sonawane added that the said fee structure is a proposed structure which will be placed before the Fee Fixation Committee of the University for approval.

Some of the suggestion made by the members for addressing the growing inflations are as below.

- ✓ Increase in outreach activities which will result in a greater number of consultancies & sponsored R&D projects.
- ✓ Establishment of new Research oriented integrated M.Tech and Ph.D programmes attracting more students.
- ✓ Maintain separate categorization of Aided and non-aided expenses.

**R-AC-1-9:** The members RESOLVED to APPROVED to send the proposal to the Fee Fixation Committee.

#### Ag-10: F Y M Tech Eligibility Criterion

Dr. Sujit Pardeshi, Over All Admission Coordinator, COEP Tech briefed the members that considering the admission statistics for the last two academic years (mentioned below), it is observed that the number of students admitted to the PG programmes has drastically declined and has raised an alarming situation for the university. One of the major reasons for the downfall is the delay in the process for the PG admission in Maharashtra. While the admission process for the IITS and NITS are held around June/July the process for PG admission in Maharashtra is held later.

As an curative measure, we have therefore proposed to the State CET Cell of Maharashtra to delink the PG admission process for COEP Tech from the Central Admission Process conducted by the State Government and undertake separate admission rounds for PG (MTech and M.Planning) programmes for COEP Technological university, Pune for the academic year 2023-24 before or around the same time period when the admission process are on for NITS and IITs, as per the rules led by the State Govt and AICTE from time to time.

The university is awaiting approval for the same from the concerned Government authorities.

He also presented the following eligibility matrix for PG programmes with revised eligibility criteria which is enclosed as Annexure-1.

The members suggested offering integrated PG programmes to attract a greater number of students. Dr. Pardeshi replied that the admission committee will soon come up with the policy for integrated PG programmes which can be implemented for AY 2024-25

**R-AC-1-10:** The members RESOLVED to APPROVE the revised eligibility matrix for various M. Tech Programmes.

The meeting was adjourned for an hour for lunch break.

# Ag-11: Recommendation of a member in the search-cum-selection committee on the Panel of selection of Vice Chancellor.

Dr. Sonawane informed all the members of the academic Council and Board of Governance that as per COEP TECH's ACT dated 10th May 2022 (Section 11 Point no (iii) page no 19) the Board of Governance and Academic Council, jointly need to recommend/ nominate one member who is the Director or Head of an institute or organization in Engineering or Technology discipline of national repute established by an Act of Parliament on the search-cum-selection committee for selection of the regular Vice Chancellor of COEP Tech.

Accordingly, Dr. Sanjay Dhande, Member of the Board of Governors, COEP Tech on behalf of the members of the Board and Academic Council suggested the nomination of Prof. Subhasis Chaudhuri, Director, Indian Institute of Technology Bombay on the said committee.
