This notice is being issued for Online submission of application form and uploading of scanned copy of original documents for E- Verification and reporting to University by aspiring candidates for admissions to First Year of Four Year Full-time **B. Planning Programme** at COEP Technological University (COEP Tech.), Pune for the Academic Year 2024-25.

Process of application form submission: The candidate shall fill online application form through application link provided on COEP Tech. website (<a href="https://www.coeptech.ac.in/admission/undergraduate">https://www.coeptech.ac.in/admission/undergraduate</a> or <a href="https://www.coep.org.in/admissions">https://www.coep.org.in/admissions</a>), the candidate shall fill and submit online application form and upload the required documents, anywhere through the computer connected to internet and he/she need not visit personally for verification of the application form. His/her application and documents will be verified and confirmed by the COEP Tech., through online mode only (refer page number 4 of this notice for detailed activity schedule).

# Documents required to be uploaded along with Application Form for Centralized Admission Process (CAP)

The candidates are required to upload ALL Original Certificates/Documents in support of their claim at the time of filling up of Application Form for Admission. The Candidates shall carry the original documents for scrutiny & verification at identified Facilitation Centre as per the process specified by the competent authority. The candidates are required to scan the document in .jpg or .gif format (minimum 150 dpi resolution, file size upto 1 MB) and upload the scanned copies of the required documents at the time of filling up Application Form for admission. The Facilitation Center shall assist the candidate, free of cost, to scan and upload the documents.

All the rules and regulations of admission for the academic year 2024-25 will be in accordance and governed by Information Brochure for Academic Year 2024-25 for admission to Full Time Professional Undergraduate Technical Courses published by State CET Cell of Government of Maharashtra (https://fe2024.mahacet.org/).
- 2. If candidate fails to upload and submit documents required to COEP Tech via online application link provided on COEP Tech's website, then such applications will be rejected, and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission.
- 3. Candidate wish to apply in EWS Category shall produce the Eligibility Certificate for Economically Weaker Section (proforma V- valid for 2024-25 on page 115 of Information Brochure published by CET Cell of Government of Maharashtra.)
- 4. Applications received after the last date shall be considered for 4<sup>th</sup> round, to be conducted through counselling, if seat remains vacant.
- 5. A candidate who has been allotted a seat shall confirm the seat by reporting (in person) at COEP Technological University, Pune with all required original documents. Non-Confirmation/ Non-reporting by candidates for the provisional allotment will be treated as cancellation of allotment to a particular seat and the seat will be treated as vacant for subsequent allotment round.
- 6. The Seat Acceptance Fees shall be Rs.1,000/- for all candidates which is an additional fee other than Application Fees paid earlier. This Fee shall be treated as non-refundable, non-transferable Fees. The Seat Acceptance Fees is to be paid through SBI Collect payment portal only.
- 7. As per the allotment, seat will be confirmed by COEP Tech. after verification of the original documents and ensuring that the Candidate meets all the eligibility norms and

payment of requisite fees. The admission in-charge of COEP Tech. shall issue the receipt of admission confirmation and fee paid to the candidate.

8. At the time of reporting to the COEP Technological university for the admission reserved

category candidates shall produce all necessary original documents for the verification and

submission to the COEP Tech. University on or before as per the notification published by

the CET cell time to time, otherwise seat allotted to such candidate shall get automatically

cancelled and the candidate shall be considered as GENERAL category candidate for next

admission round of University, if any, provided that the candidate fulfills eligibility

criteria/conditions applicable to General category candidates. Such candidates shall have to

pay difference of fees of Rs. 200/- through online mode only, if applicable.
