Announcement of Admission Round and Schedule for CIWGC, OCI/PIO/FN and NRI Candidates

Instructions for Admission through counselling rounds to First Year of Undergraduate Technical Courses in Engineering and Technology as well as B. Planning programme for CIWGC, OCI/PIO/FN and NRI Candidates at COEP Technological University (COEP Tech) Pune for the Academic Year 2024-2025.

- A. For all B. Tech. programmes (Refer Table I): Only those candidates, who have registered and confirmed online through CET portal and verified their applications at Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai-400058 as per Government of Maharashtra State Common Entrance Test Cell notification before cut-off date are eligible for counselling rounds at COEP Technological University Pune. Such candidates should apply through E-Mail to fyugadmission2024-2025@coeptech.ac.in for the admission in COEP Technological University Pune and submit the required scanned copy of original documents as mentioned in information brochure of Government of Maharashtra State Common Entrance Test Cell for the Academic Year 2024-2025, for admissions to full time Professional Undergraduate Technical Courses.
- B. For B. Planning programme: For admission to B Planning programme, CIWGC, OCI/PIO/FN and NRI category candidates shall apply afresh through E-Mail to <u>fyugadmission2024-2025@coeptech.ac.in</u>.

Dates of submission of application(s) form and scanned copies of all the essential original documents through E-Mail –From 4thAugust 2024 to 22nd August 2024 up to 11.59 pm.

The seat matrix and stages of admission process are prepared in accordance with the Information Brochure {Academic Year 2024-2025} published by Government of Maharashtra State Common Entrance Test Cell for admissions to Full Time Professional Undergraduate Technical Courses (Refer page no. 10 and 11 clause no. 5 Allocation of Seats – sub clause no. 5-Supernumerary Seats as follows)

- a) OCI or PIO, Foreign Students and the children of Indian Workers in Gulf Countries Candidates.
- (i) The Candidates having Candidature as given in sub-rule (5) of rule 5 of these rules and the children of Indian Workers in Gulf Countries shall be eligible for these supernumerary seats;
- (ii) These seats shall be subject to the maximum of fifteen per cent. (15%) of the sanctioned intake seats. Out of fifteen per cent. (15%) seats, one third shall be reserved for the children of Indian Workers in Gulf Countries and two third seats shall be reserved for OCI or PIO or Foreign Students candidates or as prescribed by the appropriate authority, from time to time:

Provided that, if seats in a course reserved for Children of Indian Workers in Gulf Countries remains vacant, then such vacant seats shall be filled in from the candidates of OCI, PIO or Foreign Students and if seats reserved for candidates of OCI, PIO or Foreign Students remains vacant then such vacant seats shall be filled in from the children of Indian Workers in Gulf Countries:

Provided further that, if any seat remains vacant in both the above quota may be filled in from NRI Candidature Candidates by the Institute who has secured prior approval from appropriate authority for the NRI seats.

- (iii) These seats shall be filled in by the institution on the basis of Inter-Se-Merit of candidates as given in rule 8 of these rules.
- (iv) Candidates' fulfilling the eligibility criteria for Foreign Nationals/PIOs/Children of Indian workers in the Gulf countries/Child or Ward of NRI shall send the printed copy of online filled & submitted application form & copy of uploaded documents by hand/speed post/courier for verification & confirmation to the designated centers notified by the Competent Authority for this purpose or as per the method prescribed by the Competent Authority for this purpose.
- All eligible and interested candidates or close relative of the candidate, with undertaking signed by the candidate for the representation of candidate, should report to the Main Auditorium of the COEP Technological University Pune for the admission process on Friday, 30th August 2024 at 11.00 AM for counselling round 1, along with prescribed COEP Technological University Pune admission fees as mentioned in Table 3 of this notification.

Candidate or close relative of the candidate should produce all the essential original documents at the time of admission process. If the candidate or his/ her close relative, with authority letter of candidate, fails to report in person to the COEP Technological University for the admission for

counselling round on **Friday**, 30th August 2024 at 11.00 AM his/her claim on the seat shall stand cancelled.

- 2. Candidates who has confirmed the application form at *Sardar Patel College of Engineering* (*SPCE*), *Versova Road*, *Munshi Nagar*, *Andheri (West)*, *Mumbai-400058 (Verifying authority)* as authorised by the Government of Maharashtra State Common Entrance Test Cell, Mumbai for Admission to First Year of Undergraduate Technical Courses in Engineering and Technology for CIWGC, OCI/PIO/FN and NRI are only eligible for admission process through counselling to the First Year of Undergraduate Technical Courses in Engineering and Technology under CIWGC, OCI/PIO/FN and NRI category at COEP Tech.
- 3. Seats available, for Stage-1 Round-1, for Admission to First Year of Undergraduate Technical programmes in Engineering and Technology as well as B. Planning programme for CIWGC, OCI/PIO/FN and NRI candidates at COEP Technological University Pune for the Academic Year 2024-2025 are depicted in Table 1 of this notification.
- 4. To participate in admission process for admission to COEP Tech, candidate is required to pay the non-refundable admission processing fee of Rs. 10,000/- (Rupees Ten Thousand Only) per application form for CIWGC, OCI/PIO/FN and NRI category through SBI collect payment portal as per the guidelines given in the below link: (https://www.coeptech.ac.in/wp-content/uploads/2024/06/Steps-to-be-followed-for-making-online-payment-through-SBI-Collect.pdf) (No other mode of payment shall be permitted.) SBI Collect payment portal accepts Credit Card / Debit Card / Net Banking etc. of many Banks. Admission processing fee paid is non- refundable. Attach the receipt generated (PDF file) after payment on SBI collect portal.
- 5. At any later stage, if a candidate wishes to withdraw from the admission process the admission processing fees once paid will not be refunded under any circumstances and no such claims / requests will be entertained.
- 6. Schedule of admission is mentioned in **Table 2** of this notification.
 - i. All the admissions to F. Y. B. Tech. programmes of AY 2024-2025 will be made strictly in the order of inter-se merit from amongst the candidates whose name appears in the confirmation list as declared by Government of Maharashtra State Common Entrance Test Cell, Mumbai and who have submitted scanned copies of all the essential original documents

through email to COEP Technological University Pune. (<u>fyugadmission2024-</u> 2025@coeptech.ac.in)

- ii. All the scanned copies of original documents should be clearly visible and legible. List of all the essential documents is as indicated in the acknowledgement received from verifying authority Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai-400058 as mentioned in Government of Maharashtra State Common Entrance Test Cell, Mumbai, Information Brochure for Academic Year 2024-2025.
- iii. Attach the scanned copy of **application verification acknowledgement** received from *verifying authority Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai-400058* along with **Application form (Annexure I)**.
- For B. Tech and B. Planning programme COEP Technological University shall publish its separate merit lists, for those who are eligible to apply for COEP Technological University Pune for admission under CIWGC, OCI/PIO/FN and NRI category for Academic Year 2024-2025.
- 8. The candidate will lose his/her claim to participate in the admission through counselling process, if he/she fails to submit all the essential original documents at the time of document verification process during counselling round on **Friday 30th August 2024**. In case a candidate has secured admission elsewhere, he/she will be required to submit copy of admissions allotment letter and/or proof stating that the original documents are **retained by the respective institute for the admission purpose.**
- 9. The details of the requisite admission fees for first year of the undergraduate programme applicable to the respective category (CIWGC, OCI/PIO/FN and NRI) is given in Table 3 of this notification.
- 10. Candidate must pay requisite COEP Technological University admission fees (as per his/her category status) immediately at the time of admission process on **Friday 30th August 2024** to confirm his/her admission if the seat is allotted. The Fees applicable (as per his/her category status) is mentioned in **Table 3**, otherwise his/her candidature will be annulled for the respective stage.
- 11. All the admissions will be made strictly in the order of inter-se merit. The seat allotment will be carried out based on the vacancy status at the moment at which candidate presents himself / herself or his/her authorized representative during the counselling round.

12. For admission to FN Category, OCI/PIO category candidate must pay COEP Technological University admission fee of US\$ 6250 (in US\$ only) or equivalent Indian rupees (INR) at the conversion rate at the time of payment + INR 54,540/- through demand drafts drawn in favour of "COEP Technological University" payable at Pune.

However, if OCI/PIO/FN category candidate is seeking admission to unclaimed seats of CIWGC category, such candidate will have to pay the requisite COEP Technological University admission fee of **US\$ 6250 (in US\$ only) or equivalent Indian rupees (INR) at the conversion rate at the time of payment + INR 54,540**/- as applicable to respective OCI/PIO/FN category of seat through **demand drafts only**, drawn in favour of "COEP Technological University" payable at Pune.

- 13. CIWGC Candidates seeking admission to CIWGC category are required to pay the requisite COEP Technological University fee of **Rs. 1,63,240/-** through **demand draft only**, drawn in favour of **"COEP Technological University"**, payable at Pune. In subsequent stages of admission counselling round, if CIWGC candidate is seeking admission to unclaimed seats of OCI/PIO/FN category, such candidate will have to pay the requisite COEP Technological University admission fee of **US\$ 6250 (in US\$ only) or equivalent Indian rupees (INR) at the conversion rate at the time of payment + INR 54,540/-** as applicable to respective OCI/PIO/FN category of seat through demand drafts only, drawn in favour of "COEP Technological University", payable at Pune.
- 14. NRI Candidates seeking admission to seats of CIWGC or OCI/PIO/FN category are required to pay the requisite COEP Technological University admission fee in US\$ 6250 (in US\$ only) + INR 54,540/- (as applicable to NRI candidature) through demand drafts only, drawn in favour of "COEP Technological University" payable at Pune.
- 15. The candidate who fails
 - i. to report to the COEP Tech University (main auditorium) as per schedule for the admission to verify essential original documents at COEP Tech University his/her claim on the allotted seat shall stand cancelled, and
 - ii. to pay the COEP Tech University admission fees in demand draft drawn in favour of "COEP Technological University, Pune", payable at Pune his/her claim on the allotted seat shall stand cancelled.

- 16. Confirmation of seat will be after immediate payment of COEP Tech University admission fees at the time of accepting the offered seat by the candidate. Candidate will be issued an allotment letter thereafter. The allotted programme of study is final; however, it may be upgraded through betterment in the subsequent stages of allotment depending upon the vacancy and the candidate's choice as per inter-se merit.
- 17. The admitted candidate should submit an online anti-ragging affidavit after confirming admission at COEP Technological University Pune on either of the following links: www.antiragging.in or www.amanmovement.org
- 18. In case of cancellation of confirmed admission at later stage, COEP Technological University admission fees paid by the candidate are refundable as per rules and guidelines of COEP Technological University and CET cell.
- 19. Only those candidates who have submitted application to COEP Technological University **through E-Mail** to <u>fyugadmission2024-2025@coeptech.ac.in</u> up to the last date along with admission processing fees shall be considered for stage I, II and III of the counselling rounds.
- 20. Candidates who have submitted application to COEP Technological University Pune through E-Mail to <u>fyugadmission2024-2025@coeptech.ac.in</u> after the last date i.e. on or after August 23rd, 2024, shall be considered for 2nd round and subsequent rounds.
- 21. All candidates must ensure that all the documents and certificates submitted must be in **ENGLISH language** only. In case if the document(s) and certificate(s) are in other than English language; the candidates must submit certified translated copies of documents / certificates in English.

Stages of admission:

I) Merit List will be prepared on the basis of inter-se merit of respective categories of CIWGC, OCI / PIO / Foreign National, and NRI Candidates and displayed on the COEP Technological University website <u>www.coep.org.in</u>/ <u>www.coeptech.ac.in</u>.

For **B. Planning programme**, merit list will be prepared and displayed on the website <u>www.coep.org.in / www.coeptech.ac.in</u> by COEP Technological University on the basis of inter-se merit of respective categories of CIWGC, OCI / PIO / Foreign National Candidates, and NRI.

Stages of Admission Round 1 for CIWGC, OCI/PIO/FN and NRI Category:

- II) Stage I will be conducted only for OCI / PIO / Foreign National Candidates and CIWGC in respective candidature/category based on the seats available in a particular programme / discipline to the candidate during the counselling round as per inter-se merit.
- III) Stage II if seat(s) remains vacant in CIWGC or OCI / PIO / Foreign National category after stage I, then vacant seats in both these categories will be clubbed together and combined round will be conducted for CIWGC and OCI / PIO / Foreign National category candidates together as per inter-se merit.
- IV)Stage III if seats remain vacant after stage II, then vacant seats in CIWGC and OCI / PIO / Foreign National categories will be clubbed together, and round will be conducted for NRI candidates as per inter-se merit.

Seat falling vacant after stage III of 1st counselling round may be filled as per above procedure in next counselling rounds as notified on the COEP Technological University Pune website. All seats remaining vacant after counselling rounds will continue to remain vacant after admission cut-off date declared by competent authority, as these seats are supernumerary in nature.
