Announcement of CAP Round- IV on 5th September, 2024

for M.Tech and M.Planning programs at COEP Technological University for the Academic Year 2024-25

Candidates Eligible to participate in CAP Round-IV:

- 1. All the candidates registered in Non-GATE Non-Sponsored category and who have given University Entrance Examination (UCET) and scored non-zero marks in the test.
- 2. All other candidates are not eligible to participate in CAP Round-IV.
- 3. Candidates must carry**Demand Draft** of requisite fees (as applicable and mentioned in the fee structure) in the name of "COEP Technological University", payable at Pune
- 4. Those candidates who will not carry such demand draft will not be allowed to participate in CAP Round-IV.
- 5. Candidates must take immediate decisions based on the availability of vacant seats and confirm their admissions by submitting the required documents & demand draft of requisite fees.

Important Instructions:

- 1. The admissions to the first year of postgraduate courses at COEP Technological University Pune in CAP Round-IV for the academic Year 2024-25 will be conducted by Counseling against vacant seats displayed on COEP Tech website.
- 2. These admissions will be made **strictly** in the order of inter-se-merit of marks secured in UCET Exam amongst the candidates who report in person for admission to COEP Tech against the seats available in various branches at that point of time.
- 3. The candidate will lose the claim to participate in the admission counseling process if he/she fails to produce all the required original documents at the time of document verification during the counseling round. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce the original receipt of admission. The candidate should submit an undertaking stating that he/she will submit original documents within four working days from the date of reporting.
- 4. The seat allotment will be carried out based on the vacancy status at that point of time. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats. Candidates are advised to be present in the Counseling Hall and wait for their turn

as per inter-se merit. If a candidate is found unavailable when called, the next candidate in the merit list will be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.

- 5. Suppose a candidate of higher merit reports late during the process of counseling. In that case, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time. The decision of the admission center in-charge shall be final and binding.
- 6. Confirmation of the allotted seat to the candidate is subject to the submission of the requisite admission fees through **Demand Draft in favor of "COEP Technological University" payable at Pune.**

If a candidate fails to pay the requisite admission fee at the time of seat allotment, such candidature will be withdrawn, and the seat will be allotted to the next candidate in the merit list. Payment through cash / cheque / online mode will not be accepted under any circumstances.
