If seats remain vacant due to betterment or cancellation, the additional spot rounds will be conducted on 13<sup>th</sup> September 2024 from 8.30 am onwards for all Maharashtra State and All India candidates. If till cutoff date and time as notified by the CET Cell, Mumbai any seat(s) remain vacant due to betterment or cancellation, multiple spot rounds for all Maharashtra State and All India candidates will be conducted on the same day. Admission round stages will be conducted as per the information brochure of GOVERNMENT OF MAHARASHTRA State, Common Entrance Test Cell, for

the Academic Year 2024-25, for admissions to full time Professional Undergraduate Technical Courses.

**NOTE for ACAP (Non-CAP) Registered Candidate:**

1. Candidates who have registered with CET CELL and Verified the documents after last date of application as per the CET Cell guidelines shall report to COEP Tech. on or before 9<sup>th</sup> September 2024, in person, for obtaining merit number as per his/her score in MHT-CET/JEE(Mains) 2024.
2. Candidates are advised to check the schedule given in Table 1 and 2 of this notification and plan to report to the venue at least 2 hours before his/her anticipated merit number in accordance with the Final Merit List Published by CET –CELL on <https://fe2024.mahacet.org>.

**NOTE for CIWGC, PIO/OCI/FN, NRI candidates:**

1. For CIWGC, PIO/OCI/FN, NRI candidates spot round will be conducted on 13<sup>th</sup> September 2024 at 1.00 PM.
2. For CIWGC, PIO/OCI/FN, NRI candidates whose name does not appear in Merit List Published, on 28<sup>th</sup> Aug. 2024, by COEP Tech. Should Report to Venue by 10.00 AM on 13<sup>th</sup> Sept. 2024.

**For F.Y. B. Tech. Admission activity during ACAP/Spot Round 2024**

Sr. No.	Activity
1	Reporting of candidates to Main Auditorium, COEP Technological University, Pune strictly as per the schedule mentioned in Table No-1 and Table No-2. <b>The entry to main auditorium is given to the candidate(s) having the requisite University fee in the form of Demand Draft ONLY and the candidate(s) not having Demand Draft of requisite University fees will not get entry into the main auditorium.</b> <b>Students who are already admitted to COEP Tech. through CAP Round I, II, III should bring DD of difference amount of fees as applicable.</b> <b>If candidate is admitted on MHT-CET/MS seat, for switching from MHT-CET seat to AI (JEE) seats, DD of Difference amount of Rs. 21,000/- is necessary.</b>
2	Payment of Nonrefundable Admission Processing fee of Rs.1500/- (One thousand five hundred only) for OPEN category as well as AI candidates and Rs.1200/- (One thousand two hundred only) for RESERVED category candidates should pay to 10 <sup>th</sup> September 2024 till 8.00 am (IST). 3	The entry to main auditorium is given to the candidates(s) having requisite University fee in the form of Demand Draft and transaction receipt of payment of non refundable Admission processing fee.
4	Verification of requisite original documents as notified by CET Cell and submission of one sets of photocopies of requisite documents.
5	Call for seat allotment shall be by counseling as per Inter-Se-Merit.
6	Submission of requisition form for seat allotment.

7	Payment of University / Institute Admission Fee in the form of <b>Demand Draft ONLY</b> issued in favor of “ <b>COEP Technological University</b> ” Payable at Pune.
8	All candidates except ST category candidates who will get admission or betterment through Institute / Spot / ACAP round need to pay University fee applicable to OPEN category. The fee structure is available on COEP Tech website. i.e The fees for spot round(s) is as follows: 1. The candidate admitted through MHT-CET is Rs. 1,42,240/- 2. The candidate admitted through All India (AI) JEE Main is Rs. 1,63,240/- 3. The candidate(s) must bring the DD(s) of appropriate amount of University fees as applicable.
9	Seat allotment based on available vacancy at that moment.
10	Submission of required original documents along with one set of photocopies of these documents.
11	Confirmation of the allotted seat to the candidate.
12	Issue of admission confirmation receipt to the candidate.

### Instructions:

1. The admissions to the first year of undergraduate courses / programs at COEP Technological University, Pune for the Academic Year 2024-25 will be conducted by Direct Counseling (Spot) Round against vacant seats available after CAP-III round of CET CELL for the admission for the Year 2024-25.
2. These admissions will be made strictly in the order of Inter-Se Merit amongst the candidates who report in person for admission to main auditorium at COEP Technological University, Pune against the seats available in various programs at that moment.
3. The candidate will lose his / her claim to participate in the admission counseling process if he/she fails to produce all the applicable original documents at the time of document verification during the counseling round. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce the original admission letter and fee receipt. The candidate should submit an undertaking stating that he/she will submit original documents within four working days from the date of reporting.
4. After payment of admission processing fee (as applicable to F.Y. B.Tech. all including CIWGC/ OCI/PIO/FN/NRI Candidates) and successful verification of the relevant original documents, further eligible candidates will be called for seat allotment by counseling as per Inter-Se Merit.
5. At the time of seat allotment by counseling, the candidate is required to submit “**Requisition for Seat Allotment.**”
6. The seat allotment will be carried out based on the vacancy status at that point of time / moment. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats displayed on the auditorium screen. Candidates are advised to be present in the Counseling Hall (main auditorium) and wait for their turn as per Inter-Se Merit. If a candidate is found unavailable when called, immediately the next candidate on the merit rank would be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.

7. If a candidate of higher merit reports late during the process of counseling; in that case, the candidate may be considered for allotment of a seat available at that point of time / moment for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that moment. The decision of the admission center in-charge shall be final and binding.
8. Confirmation of the allotted seat to the candidate is subject to the payment of the requisite University / Institute admission fees in **Demand Draft** issued in favor of "COEP Technological University" Payable at Pune, applicable original documents, anti-ragging form and academic bank of credits (ABC) immediately in online mode, such candidate confirms admission through the acceptance of the allotted seat at COEP Technological University, Pune.
9. If a candidate fails to pay the requisite University / Institute admission fee **Demand Draft** issued in favor of "**COEP Technological University**" Payable at Pune at the time of seat allotment, such candidature will be withdrawn, and the seat will be allotted to the next candidate as per Inter-Se-Merit. Any other payment mode will not be accepted under any circumstances.

	Tuition Fees and Exam Fees will be waived 100% for Girls Studnets of EWS, SEBC, EBC, OBC, VJNT, Category whose family income is less than Eight Lakh as per Govt. GR. Dated 08th July 2024. Exam Fees of such Girls studnets will be directly credited into their bank account through MahaDBT portal, such Girl studnets have to pay the Exam Fees to the University.
