Performance Security Deposit / Bank Guarantee:

Performance Security Deposit / Bank Guarantee (Nationalized Bank only) for an amount 5% value of the contract (if order is placed) is to be submitted immediately after accepting the purchase order. The performance security must be valid during the warranty period i.e. for Three years For Batteries. The same will be returned without any interest after completion of the warranty period.

Verification of Bank Guarantees:

Bank Guarantee submitted by the Bidder as Performance Security is subject to verification from the issuing bank by purchaser before its acceptance.

Warranty / Support:

- 1. The items covered by the schedule of requirement shall carry minimum **Three years** of comprehensive warranty from the date of acceptance of the batteries by **COEP**, Tech. University, Pune. The warranty shall include free maintenance of the whole battery supplied including free replacement of parts. The defects, if any, shall be attended to on an immediate basis but in no case any defect should prolong for more than 24 hours. The comprehensive warranty includes onsite warranty with parts.
- 2. The defects, if any, during the guarantee/warranty period are to be rectified free of charge by arranging free replacement wherever necessary. This includes cost and insurance.
- 3. The batteries must be supported by a Service Center in Western India (Pune and Mumbai Region) manned by the principal vendor's technical support engineers. The support through this Center must be available 24 hours in a day, seven days a week and 365 days a year. Also, it should be possible to contact the principal's vendor support Center on a toll-free number/web/mail.
- 4. An undertaking from the manufacturer is required in this regard stating that they would facilitate the BIDDER on a regular basis with technology / product updates & extend support for the warranty as well.
- 5. Commencement of Warranty period: The warranty period of battery shall commence after the date of its satisfactory installation/ commissioning/demonstration at the project site in COEP, Tech. University, Pune. The warranty period shall be extended for the period of delay in satisfactory installation and delay in warranty services.
- 6. Technical specification in the format as Annexure-I.

Terms and Conditions:

- The bidders are advised to visit the department concerned in the University campus, study the UPS system and space available for batteries with prior permission from the Electrical Works Committee.
- 2. The required accessories for installation, testing and commissioning of new batteries will be scope of bidder, which includes termination, cable loops of suitable size and grade, etc. Battery Interlink cables / UPS to Battery Cables with suitable Lugs to be supplied by bidder.
- 3. At the time of installation arrangement in rack, labeling of battery for number and date of installation will be done by vendor. Installation should be done by a highly skilled service engineer with adequate labor support. The presence of OEM engineers of UPS at time of battery replacement is mandatory and any charges payable to the UPS OEM and battery OEM is in scope of bidder.
- 4. All safety norms as per IS code should be followed by the bidder for manufacturing, transport, installation and commissioning.
- 5. The deliverables should be supplied strictly within 4 weeks of the date of the issue of Purchase order.
- 6. Each bidder shall submit only one quotation with the Manufactures Authorization Form (MAF).

7. Penalty for delayed services / LD

If the supplier fails to Supply, Install and Commission the system as per specifications mentioned in the order within the due date, then penalty shall be changed

a) at the rate of 0.5 % per week and maximum limit of 10% in case of PO value is less than 2 Lakh.

OR

b) at the rate of 0.5 per week; maximum limit of 5% in case of PO value is 2 Lakh and above.

8. Special Conditions for the work:

8.1 If during the course of installation and commissioning within the premises of COEP, Tech. University, Pune any mishap/accident occurs causing injuries to the employees or representatives of Bidder/agency/firm, necessary

- compensation as required by the statute will be borne by Bidder/agency/firm itself, and College of Engineering Pune is indemnified against all claims on such accounts.
- 8.2 All the staff deployed by Bidder/agency/firm will ensure that they are polite and courteous in their behavior. They shall carry their photo identity cards prominently displayed during the working hours.
- 8.3 The Bidder/agency/firm shall not do or cause to do or permit to do any act which would amount to nuisance or annoyance to **COEP**, Tech. University, Pune and shall not do or permit to do any immoral acts in the premises of **COEP**, Tech. University, Pune and shall not do any act or things where by **COEP**, Tech. University, Pune suffers any loss or damage or which may cause any disturbance to **COEP**, Tech. University, Pune.
- 8.4 All work shall be carried out with due regard to the convenience of **COEP**, Tech. University, Pune. The orders of the authority concerned shall be strictly observed.
- 9. Quotations will not be entertained by E-mail / FAX.
- 10. All duties, taxes and other levies payable by the bidder need to be included in the total price and break-up needs to be indicated.
- 11. We look forward to receiving your quotations and thank you for your interest in this project.

12. Payment Terms & Conditions:

100% payment shall be made at the earliest after successful Delivery, Installation, Commissioning, and Testing of the batteries and acceptance of old batteries. No advance payment will be given.

- 13. Bids received after the last date of bid submission will be rejected.
- 14. The vendors shall have to quote for all the items of the Quotations. Part Quotation /incomplete Quotation shall be summarily rejected.
- 15. Offers in the bid should be written in English and price should be written in both figures and words.
- 16. Flat Discount for battery purchase will be accepted. Taxes and other levies/duties to be quoted separately.
- 17. The university reserves the right to decide the quantity of any of the items of Quotations for finalizing the purchase order without any reason.
- 18. The university reserves the right to cancel any of the items of the Quotations without any reason thereof.

- 19. The university reserves the right to accept or reject any or all quotations.
