This single PDF file is required to be uploaded in the online google form.

- 2. The last date for the receipt of the ONLINE application Google form is **30**th **April 2025 till 5:00 p.m.**
- Printout of the online application form submitted with attested copies of requisite certificates and receipt of fees paid should be submitted to the University office on or before 30th April 2025 up to 5.00 pm in an envelope prescribed as:

5. Candidates must also bring all the relevant original certificates/documents along with photo ID proof for verification at the time of scrutiny. The hard copies of duly filled in application with signature and photograph with all required self-attested copies of the certificates/documents will have to be submitted at the time of written test/presentation to the University authorities. 6. Candidates who wish to apply for more than one discipline should submit **separate applications** along with respective fees receipt.

B. Selection Procedure

- In case the number of applications received is large, a Written Test will be conducted for short listing of candidates for presentations and Interview. The written test paper will be objective type based on GATE/CAT/CMAT syllabus for respective branch/subject.
- 2. Round I Presentation at Department Level Relevant subject (Presentation based on Subject knowledge and presentation skills)
- 3. After round I, shortlisted candidates are eligible for Round II for Interview at University level.
- 4. Round II **Interview** at University Level (Personal interview in front of Selection Committee)

After round II, selected candidates will be communicated by email.

C. GENERAL INSTRUCTIONS TO CANDIDATES

- 1. The candidate applying for the post of Non-Vacation Tenured Assistant Professor on 3-Years tenure (Purely Contract) basis on dying positions should apply separately for each discipline.
- 2. Knowledge of Marathi is essential
- Adjunct Faculty currently working at COEP Technological University can also apply.
- 4. The candidates who have submitted a Ph. D. thesis are also eligible to apply.
- 5. Applications received after the last date will not be considered. The University will not be responsible for postal delays, if any.
- 6. Candidates are advised to satisfy themselves before applying that he/she possesses the prescribed qualifications. **No inquiry asking for advice about eligibility will be entertained**.
- 7. Candidates applying for the post should have educational qualifications, experience of respective discipline as per the latest educational qualifications experience norms and Age criteria of AICTE/UGC/Govt. of Maharashtra's resolutions published from time to time.
- 8. The appointment is Non-Vacation Tenured Assistant Professor on 3-Years tenure (Purely Contract) basis on dying positions, a maximum salary per month of Rs. 1 Lac to 1.20 Lacs as per the recommendation of Selection Committee.

- 9. Services shall stand automatically terminated; on expiry of tenure of 3 years or if the performance of the selected candidate is not satisfactory on review after every 11 months of the service.

Reserved category candidates must attach a valid caste certificate and caste validity/ non-creamy layer certificate issued by the competent authority, along with the application and candidates belonging to EWS, SEBC category must attach a valid income certificate issued by the competent authority.
- 11. No TA / DA will be paid to the candidate to attend a written test/presentation and interview.
